City of Lakeland Onsite Stormwater Facility Credit Application Form

Stormwater Utility customers may receive an exemption or credit in fees for the construction, operation and maintenance of Stormwater treatment facilities on the billed property. Customers seeking a credit must submit an application to the Director of Public Works. Following the initial approval, the customer must demonstrate every three years that the facility is properly maintained and operating in accordance with design and permit conditions.

To obtain credit for a facility, copies of permits from the Southwest Florida Water Management District (SWFWMD) must be submitted with this application. If the facility was constructed prior to the requirement of permits by the SWFWMD, credits may still be obtained if sufficient documentation is provided.

B. Where SWFWMD permit does not apply:

For facilities that were constructed prior to SWFWMD requiring permits, but which provide Stormwater quality treatment equivalent or according to the City's Land Development Regulations, the applicant must provide:

- As-built construction and drainage plans, and specifications and drainage calculations prepared and certified by a professional engineer licensed in the State of Florida.
- Photographs of the facility that were taken within one (1) year prior to the credit application date.
